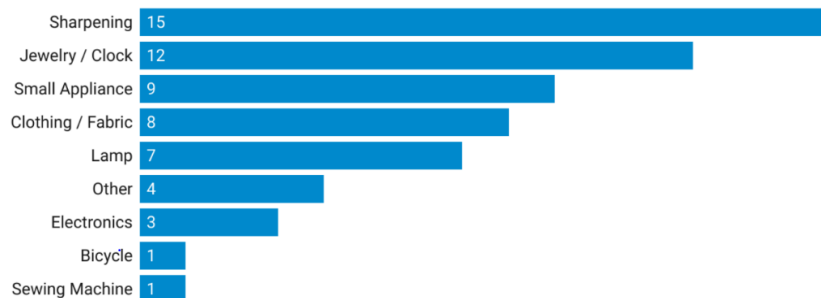

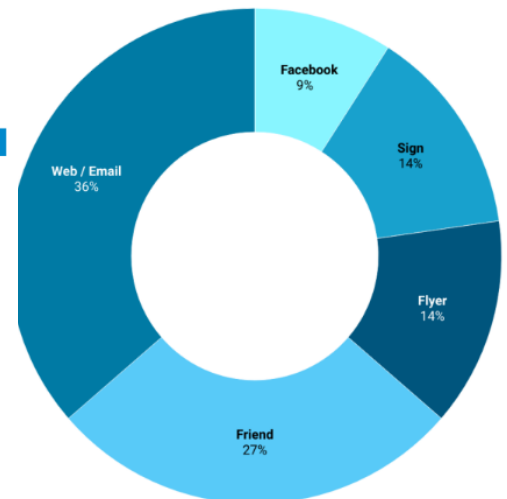
Repair Cafe Visitors

- **NEXT DATE Earth Day 4/22**
 - Steve is putting together numbers on items repaired so far over the course of Repair Cafes.
 - Goal for advertising:
 - Spanish translation for advertising Repair Cafe to increase equity in reach.
 - Posters up a full 6 days earlier

- Sign placement - consistently get up to Tivoli.
- Stakes for signs - we need replacements / buy a few extras?

Materials Management

- Compost - Proud Composters
 - Lori and Frances met about goal of expanding compost program. Currently: 4 bins, mostly full by end of week. Adding 2 bins adds \$118 per month. Another outreach push? Give out more buckets at Earth Day? Increase number of bins ahead of push, or in response to increased use?
 - Leah noticing some people still have concerns about smell of food scraps. Jen suggested recommending they keep bucket in fridge. Lori has ½ the stickers; TJ has the other half to hand to people as they pay for their bags of trash - let them know they can make their bag smaller.
 - Will meet with Amelia (O Zone) on Feb 28th.
 - Kerry Russell from Dutchess County says the County does not have money at the moment for municipalities but is on a listening tour to consider support through budget for next year.
 - Mostly, Lori is finding that grants are funding the launch and equipment of programs, not operations.
 - Other question: expand to businesses? Will consult with Amelia.
- E-waste - how do we improve access - what does TJ say?
 - Important to make E-waste day available. Laurie cannot lead this year; need someone to step in.
- Paper Shred / Clean Up Day
 - Paper Shred does not seem like CAC scope. Could happen on clean-up day, both run by Board members.

- Town Board public hearings
 - Local Law No. B (Proposed) of 2023 entitled “A LOCAL LAW TO AMEND THE ZONING LAW, CHAPTER 143, OF THE TOWN CODE OF THE TOWN OF RED HOOK REGARDING INCENTIVE ZONING” to encourage the use of the incentive zoning for the protection of open space and to encourage the development of affordable housing and the location of housing in the TND (traditional neighborhood development district).
 - B: Town implemented an incentive zoning code and fund for developers who are developing in the TND area. They can have additional density on that land if they pay into a fund. This fund used to only be allocated towards preserving ag lands in the ABD. Town Board finds this too limiting, and would like to extend it to apply to other areas.
 - C: Open space: gives steps for the Town to acquire properties with the ability to “alienate” portions of them (not retain the full property).
 - Setting a Public Hearing on the open space acquisition and preservation of Cookingham Farm (East)
 - 90% under conservation easement, 10% set aside for affordable single family housing.
- DEC camps
 - Jen is waiting to hear from the Masons; VFW waiting on board approval; sign-up will start in April.
- Ruth Oja scholarship
 - April 1 deadline. Jen is putting on Facebook and working with RHCS D
- Energy cte - any discussion around overlap areas?
 - Agrivoltaics - supervisor requesting he get a map with a few criteria (Denis to share)
 - Michael from Sawkill farms is interested in putting together a business plan for agrivoltaics. This would be dependent on zoning change from the town.

- Denis recommends we ask Audrey Freidrichsen (Scenic Hudson) for potential guidance on amending conservation easements.
- Frances and Denis working on using Solar Mapping Tool to identify potential sites. What properties are under easements. Where is the 3 phase access (3-phase lines are limiting in our area). Existing generation and capacity. Also, there's already a lot of distributed generation in the queue on many lines with capacity.
- CCA update from Town Supervisor:
 - A suggested hybrid model: pricing fixed for 3-4 months out. Loosely corresponding to utility rates, but slightly discounted. Opt-out model. Town still has to decide about moving forward, within the next month or two. The advantage is it doesn't pitch ESCO against participants - success is together
 - Previously, other municipalities have offered 2 options - clean or mixed; Red Hook is committed to renewable energy.
- (School energy, solar, & building audit, electric buses)
 - Denis has talked to TetraTech, and Hannah Morgan from NYSERDA P-12 clean energy program. RHCS D has applied for funding to do a feasibility study!
 - Asked TetraTech for current status in the design process.
 - Allocated budget for oil has doubled relative to last year. Additionally, all institutions will likely be mandated to come off fossil fuels within 10-15 years; these systems will then have to be decommissioned.

Breakout groups 8-8:15

- Energy Efficiency and Conservation Block Grant (EECBG) program
 - **Local governments and Tribes can apply through January 31, 2024.**
 - **However, it is important to note that all eligible entities that intend to apply must submit their Pre-Award Information Sheet by April 28, 2023.**
 - **IS THERE A BENEFIT TO APPLYING EARLIER RATHER THAN LATER IN THE APPLICATION WINDOW?**
 - We encourage applicants to take their time developing robust, thoughtful strategies that inform detailed applications. Because this is not a competitive grant, all eligible governments and Tribes are entitled to the full allocation indicated in the allocation tables available on the EECBG Program website. However, the sooner that you submit your application, the sooner you will have access to your funding.
- What do we want to apply for? We don't know how much money it would be. Jen suggests we propose a suite of actions we would take, depending on the amount of money.
 - Revamp Energy & Climate Action Plan
 - Highway Garage heating system conversion
 - Microgrid feasibility study
 - Organics facility (Village of Rhinebeck just received a grant - \$300,000). Material conservation programs are within the scope of this grant.
