Mapping tool opportunity with Cornell Cooperative Dutchess County for Local Conservation Planning:
September 10, 9am-12pm

Laurie touched base with Jen as Village about Climate Action Plan (opportunity for funding/help), not interested right now.

- Dropping because only makes sense as Village/Town
- And Bard CEP intern this fall fell through

The expected timeline for CSC support services over this two-year grant are as follows.

- Government Operations GHG Inventories – Fall 2022
- Government Operations Climate Action Planning – Winter 2022-23
- Community GHG Inventories – Spring/Summer 2023
- Community Climate Action Planning – Fall/Winter 2023-24

Frances willing to put in hours if other interest.

How do we reboot how we reach people?

- Repair Cafe as pilot “how do you hear about things/us” in Red Hook
- Denis: Daily Catch is effective at bringing up highlights about what’s going on locally. Weekly highlight about clean energy (not just local, but e.g. legislation)? Revisit idea of being a clearinghouse for questions about solar, incentives, etc.? People do like instant gratification, though.
- Lori: Denis’s point about the IRA (Inflation Reduction Act) is a good one, there will be a lot of questions about rebates, incentives, etc.
- Frances intro’d HVCAN - online network for climate-engaged. Can create IRA resources for FAQs for town residents that CACs and similar can use.
- Lori: Should we have an IRA celebration? Include tables about what it means for Red Hook? Steve suggested host at Hardscrabble? Or Repair Cafe? Go where the people are: Hardscrabble. September 17th.
- Laurie: back to IRA FAQs - case studies of who’s done it and what worked. Also 45-min phone calls available with energy expert. NYers for Clean Power energy coaching (Post to FB page). Denis gets 2-3 calls per week asking about energy.

- We also need a clearinghouse for trusted sources, like we did for solar, to direct people to fair pricing.
- Lori: let's each come next month with ideas about how to extend info about IRA clean energy investments. We're in the window right now where people are thinking about this. Wait until the incentives are set—but there are also incentives already now.
- Mike: do we have a forum on the FB page? No, it's a profile not a group. Revisit? Energy committee FB page? where there's Q&A option.

Summaries:

- Review next month when all are done
- Refrigerant recovery progressing, now at about 6 per hour
 - R2D2: Refrigerant Recovery for Destruction/Distribution
 - Tshirts? Budget to tshirt making?
 - Denis: Should we have a goal for lbs refrigerant recovered? We should figure out the education element: so people remember to bring their AC to town hall. Steve emphasized importance of making it something people can comprehend e.g. car miles. Laurie pointed out that heat pumps coming in means ACs coming out.

Repair Cafe: October 1! Works with gala, hardscrabble,

- Mike, Steve, Frances are all yeses. Those who can't attend can contribute baked goods, e.g.
- Tying in broken ACs: if can't repair, bring to R2D2.

Sustainable Red Hook: a few areas for CAC to lead on

- Resource use: create list of suggested best practices, adopt codes to be better stewards, create incentives to implement. Consult impacted parties, community engagement program about resource use incl. Climate change mitigation, resilience, adaptation. Research, interrogate, co-develop, and transparently share best practices in each sector.
- Another party! By Sustainable Red Hook Audubon group = Sara @ Community Center, Erin from civic engagement, Christine Kane (town board member)
 - (Not the birds)
 - Audubon certification = 15 focus areas, it started for golf courses.
 - Laurie has a chart we should fill out. It's over the next month so we might do it online alone.
 - Fit in what we're doing to the chart

Mike moved to adjourn, Frances second, meeting closed at 8:01.

Post-meeting note: Hardscrabble heat pump focus. Could also collect FAQs. e.g. "do heat pumps work in the cold?" + a drawing. And people who can't come that day can help put together info. Appropriate season because heating season coming up. Mike: C3PO heat pump?
