RHCSD projects

- Stuck right now, Denis has not met with architect. Pitched to 5 school board members that were at facilities meeting: NYSERDA grants that are available (K-12).
- Denis planning to network with people he knows about how to effectively get this moving (April 24?)
- Jen: they were planning to move straight into design (design to replace units)
- Laurie: We need to think towards getting off fossil fuels, and building audit is easy first step
 - What's the equipment? Laurie will call Scott at facilities and check in about audit, including lighting.
- New York State: all electric buses (2035?)
- This can be an economics issue – saves money, not just climate

- Other entry point: solar going forward, opportunity to celebrate reduced electric bill
